REQUEST FOR APPLICATIONS (RFA) 18-10123 STATEWIDE COORDINATING CENTER FOR RURAL COMMUNITIES

- Purpose:** The purpose of this RFA is to fund one (1) Rural Statewide Coordinating Center (Coordinating Center) grant. The purpose of the Coordinating Center is to foster interactive and integrative collaboration and communication among awardees funded by *RFA #18-10122 Regional Rural Initiative to Reduce Tobacco-Related Disparities* (expected release date: June 28, 2018*), and other CTCP-funded projects focused on rural communities. The Coordinating Center is expected to accelerate the adoption, implementation, and impact of policy and system change campaigns conducted by projects funded under RFA #18-10122.
- Statutory Authority:** California Health and Safety Code Section 104350-104445.
- Term:** **March 1, 2019* through February 29, 2024***
- Funding:** Funding will be available from the *California Healthcare, Research, and Prevention Tobacco Act of 2016*, Proposition 56. The total amount of funding available is estimated to be up to **\$2,500,000*** for the 60-month grant period. Funding is contingent upon available revenues and appropriations by the Legislature and the Governor's Budget for fiscal year (FY) 2018-19 and subsequent FYs. Local Lead Agencies (LLA) are ineligible to apply for this RFA unless the LLA is a participant within a consortium of community-based or nonprofit organizations.
