**RE: Senate Bill 1 – SUPPORT  
As Amended March 30, 2017**

Dear Senator Beall:

On behalf of the Rural County Representatives of California (RCRC), I offer our support for your recently-amended Senate Bill 1, which addresses funding for improving our state and local transportation needs.

RCRC is an association of thirty-five rural California counties, and the RCRC Board of Directors is comprised of elected supervisors from those member counties. Rural county supervisors are extensively involved in transportation-related issues on two primary fronts: 1) Boards of Supervisors oversee public works directors/departments and subsequently help maintain the road network of their respective county; and, 2) many Supervisors sit as members of local transportation planning agencies where determining and funding projects are prioritized and developed.

The RCRC Board of Directors does not take lightly the notion of raising motor vehicle fuel taxes and other levies on motorists. Often times, these taxes can become punitive to rural drivers who must travel greater distances for school, work, shopping, and health care services. And, many low-income rural motorists will see a disproportionate amount of their household budgets devoted to the levies that are spelled-out in SB 1. Ideally, RCRC member counties would like to see a serious revision of laws and policies that ultimately deliver both state- and locally-sponsored transportation projects in a less expensive and timelier manner. However, our members recognize that our state and local road infrastructure is in a perilous condition. And, if new resources are not devoted to rehabilitate our transportation assets within the next several months, the costs will increase dramatically.


