Approval of Minutes of the November 14, 2018 Meeting

Supervisor Stacy Corless, Mono County, motioned to approve the minutes of the November 14, 2018 RCRC Executive Committee Meeting. Supervisor Rex Bohn, Humboldt County, seconded the motion. Motion passed.

**RCRC Supporting Gubernatorial Appointments** 

Paul A. Smith, Vice President Governmental Affairs, discussed the controversial topic of RCRC offering a "support" position for gubernatorial appointments during their State Senate confirmation process. The Executive Committee discussed at length the various pros and cons to supporting individuals who have been involved in bettering rural California. If the RCRC Executive Committee wishes to move forward and support gubernatorial appointments that require Senate confirmation, the RCRC bylaws will need to be amended. Mr. Smith reviewed the RCRC bylaws, particularly Section 6.7.2 regarding Powers and Limitations of the Executive Committee. Under a revised policy, staff would inform the Chair of the individual who would be considered for support from RCRC. And, the Chair would take it to the Executive Committee whereby a 2/3rds vote of the Executive Committee would be required to formally garner support for a nominee.

Supervisor Rex Bohn, Humboldt County, motioned to present this proposed RCRC Baylaws amendment to the full RCRC Board of Directors for adoption. Supervisor Stacy Corless, Mono County, seconded the motion. Motion passed by a roll call vote:

NACo Legislative Conference

Paul A. Smith discussed the activities taking place in Washington D.C. in the coming week when the RCRC Officers and staff will be traveling to the NACo Annual Legislative Conference. Mr. Smith briefly discussed the issues that they will be advocating for: 1) the Secure and Fair Enforcement Banking Act of 2019; 2) enactment of a Secure Rural Schools Endowment Fund; and, 3) enactment of a rural infrastructure package. He noted that the attendees will be receiving a preliminary agenda ahead of the trip. And, a private meeting with the Director of the United States Forest Service is on the calendar.

# State Legislative Update

Paul A. Smith reported to the Executive Committee that Friday, February 22nd is the bill introduction deadline. RCRC staff will be busy reviewing an overwhelming amount of bills over the next couple weeks. Mr. Smith expects legislation will be unveiled regarding land-use and fire issues. Mr. Smith also believes that there will be a variety of cannabis-related bills that could involve licensing at the local level. One such cannabis measure is Senate Bill 67 where RCRC has been involved. Mr. Smith also noted that staff is very involved with the writing of a regulatory bill regarding hemp.

# RCRC Quarterly Budget and Investment Reports

Lisa McCargar, Chief Financial Officer, presented the Quarterly Investment Report, the Budget Report, and the Liquidity Report for period ending December 31, 2018.

# April/May Board of Directors Meeting

Justin Caporusso, Vice President External Affairs, provided a brief overview of the 2019 County of the Chair Board Meeting. This year's meeting will be held in Furnace Creek (Inyo County) on April 30 – May 2. There will be a dinner and activity on April 30<sup>th</sup> followed by a full day of tours on May 1<sup>st</sup> and the Board of Directors dinner. The Board of Directors meeting will be held the following morning on May 2<sup>nd</sup>.

# Altering Dates of the Board of Directors Meetings in Sacramento

Paul A. Smith informed the Executive Committee that during the January Board of Director's Meeting, Supervisor Michael Kelley of Imperial County inquired about the possibility of moving the dates of the RCRC Board meetings held in Sacramento. Supervisor Kelley suggested moving the meetings from Wednesday to Thursday as this would likely lessen travel-related challenges for many board members. Supervisor Kelley also pointed out that all the RCRC Member Counties meet on Tuesdays. Mr. Smith relayed this discussion from January to the RCRC Executive Committee to seek their feedback. It was agreed upon that this issue would be addressed during the next Board of Directors meeting.

# Conference with Legal Counsel – Initiation of Litigation

The Rural County Representatives of California Executive Committee convened a closed session at 1:18 p.m. pursuant to Government Code Section 54956.9(d)(1) regarding County of El Dorado et al. v. Superior Court (Austin), California Court of Appeal, Third District, Case No. C088409 – RCRC Participation as Amicus Curiae.

# At 1:25 p.m., the closed session of the RCRC Executive Committee was adjourned and the Executive Committee reconvened the open session.

Upon direction of the Chair, Supervisor Matt Kingsley, the General Counsel reported that the Executive Committee of the Board of Directors of the Rural County Representatives of California in closed session, February 20, 2019, authorized the

General Counsel to represent RCRC as amicus curiae in California Court of Appeal, Third District, Case No. C088409, County of El Dorado et al. v. Superior Court (Austin). The substance of the litigation matter concerns the proper remedy and statute of limitations for a local agency's failure to make the required "five year" findings under the Mitigation Fee Act. The vote was unanimous by all members present.

### <u>Summary</u>

This memo addresses the possibility of RCRC supporting Wade Crowfoot, Governor Gavin Newsom's appointment to serve as the Secretary of the California Natural Resources Agency. If approved, RCRC would convey its support during the confirmation process in the State Senate.

#### Background

Under the State's Constitution, the Governor is afforded a large number of appointments to head various state agencies. Furthermore, the Governor appoints hundreds of individuals to various state and regional boards and commissions. Most, but not all, senior appointments require the advice and consent of the State Senate. The review of gubernatorial appointments is primarily conducted by the Senate's Rules Committee, which is chaired by the Senate President pro Tempore (the effective leader of the State Senate). The Senate Rules Committee is comprised of five members – currently three Democrats and two Republicans. Assuming the consent of the Rules Committee, the name is subsequently brought to the Senate Floor for consideration. The overwhelming majority of appointees are subject to majority vote approval; however, some must be confirmed by a 2/3rds vote. Typically, an appointment by the Governor allows an individual to be seated immediately; however, Senate confirmation must occur within one year of the appointment.

#### ssue

Mr. Crowfoot was appointed Secretary for the California Natural Resources Agency by Governor Newsom on January 11, 2019. Secretary Crowfoot brings more than 20 years of public policy and environmental experience to the office, with expertise in water, climate and sustainability issues. He most-recently served as chief executive officer of the Water Foundation and led its transition into an independent organization early in 2017.

Prior to joining the Foundation, he served in Governor Jerry Brown's Administration as deputy cabinet secretary and senior advisor to the Governor, leading the

Administration's drought response efforts. He previously served as West Coast regional director for the Environmental Defense Fund and a senior environmental advisor to then-San Francisco Mayor Newsom.

# **Staff Recommendation**

RCRC staff recommends the RCRC Executive Committee support the gubernatorial appointment of Secretary Crowfoot during the confirmation process in the State Senate. Secretary Crowfoot has an established relationship with RCRC and its member counties and understands the rural county perspective. In his previous capacity as Deputy Cabinet Secretary for Governor Edmund G. Brown, Secretary Crowfoot worked closely with RCRC member counties and staff on the Governor's Tree Mortality Task Force to ensure immediate action and allocation of state resources to counties for tree removal projects, and also in joint requests to Congress on vital forest and water policy issues. Secretary Crowfoot has already taken steps in his new role to improve the current Forest Management Task Force at the request of RCRC and others, facilitating the appointment of now former Placer County Supervisor Jennifer Montgomery as the new Task Force leader. RCRC anticipates continuing our strong relationship with the Secretary should he be confirmed.

It should be noted that a 2/3rds vote of the RCRC Executive Committee is required to formally garner support for a nominee.

#### Summary

Most, but not all, senior appointments require the advice and consent of the State Senate. The review of gubernatorial appointments is primarily conducted by the Senate's Rules Committee, which is chaired by the Senate President pro Tempore (the effective leader of the State Senate). The Senate Rules Committee is comprised of five members – currently three Democrats and two Republicans. Assuming the consent of the Rules Committee, the name is subsequently brought to the Senate Floor for consideration. The overwhelming majority of appointees are subject to majority vote approval; however, some must be confirmed by a 2/3rds vote. Typically, an appointment by the Governor allows an individual to be seated immediately; however, Senate confirmation must occur within one year of the appointment.

#### Issue

Chief Porter was designated Acting Director of CAL FIRE by Governor Jerry Brown on December 14, 2018. On January 8, 2019, Chief Porter was appointed to serve as the Director of CAL FIRE by Governor Gavin Newsom. Previously, he served as the Southern Region Chief, Assistant Region Chief, and San Diego Unit Fire Chief.

Chief Porter's depth of fire department management expertise is balanced by his forestry background. He is a Registered Professional Forester in California with a Bachelor of Forestry Degree from the University of California, Berkeley.

# Staff Recommendation

RCRC staff recommends the RCRC Executive Committee to support the gubernatorial appointment of Chief Porter during the confirmation process in the State Senate. Chief Porter has already been working closely with RCRC member counties and staff on fuels treatment, wildfire prevention, tree mortality, and other important programs and issues. He has been extremely responsive to county concerns regarding local CAL FIRE unit response and staffing, and as a registered professional forester has made an even stronger commitment to broadening CAL FIRE's attention to forest health programs to prevent future catastrophic wildfires and restore California's forests.

It should be noted that a 2/3rds vote of the RCRC Executive Committee is required to formally garner support for a nominee.
