# Discussion and Possible Direction Regarding Region Reassignments to Equalize the Number of Counties Among the Regions

Maggie Chui, Director of Board Operations, and Arthur J. Wylene, General Counsel, presented the potential region reassignment of El Dorado County from Region 4 to Region 2 and Imperial County from Region 5 to 4; or, El Dorado County from Region 4 to Region 2 and Madera County from Region 5 to Region 4 to maintain balance among the regions.

Following discussion, the RCRC Executive Committee directed staff to consult with RCRC Board Members from El Dorado, Imperial, and Madera Counties regarding the two reassignment options, and indicated that if the Board Members unanimously supported one option, that recommendation could be placed on the consent agenda at a subsequent meeting of the RCRC Board of Directors.

### Approval of Audited Financial Statements – December 31, 2022

Milena De Melo, Finance Director, presented the RCRC 2022 audited financial statements. Ms. De Melo reviewed the financial statements, the performance for the year, the net position, and performance compared to the budget.

Eric Will, Policy and Local Assistance Manager, presented on efforts to support funding opportunities and programs for Member Counties.
