## RCRC Welcomes Solano County to Membership

*Association Now Represents 60 Percent of California's Land Mass and  
14 Percent of California's Population*

**SACRAMENTO, CA** – The Rural County Representatives of California (RCRC) has added Solano County to its membership, bringing the total number of RCRC member counties to thirty-nine. The RCRC Board of Directors approved the addition at their March 9, 2022 meeting. Supervisor Mitch Mashburn will serve as the Delegate and Supervisor John Vasquez as the Alternate on the RCRC Board of Directors representing Solano County.

“We are excited to welcome Solano County into RCRC membership to assist in our efforts to improve the quality of life for rural Californians,” said RCRC Board Chair and Nevada County Supervisor Dan Miller. “With the addition of Solano County, the collective voice of rural California is further strengthened, and we look forward to working together for the benefit of our communities.”
