RE: H.R. 6012 – Fire Safe Electrical Corridors Act of 2023- SUPPORT

Dear Congressman Carbajal:

On behalf of the Rural County Representatives of California (RCRC), we support your H.R. 6012, the Fire Safe Electrical Corridors Act. RCRC is an association of forty rural California counties, and the RCRC Board of Directors is comprised of elected supervisors from each member county. RCRC has long advocated for projects and programs that help reduce the risk of future wildfires, improve forest health, and enhance energy resiliency.

RCRC member counties contain much of California's forested lands, including more than 70 percent of the state's national forest lands. Our counties have historically borne the majority of destruction caused by high severity wildfires, many of which have been caused by electrical utility equipment. As such, it is crucial that utilities regularly inspect and maintain their infrastructure, including proper vegetation clearances around utility equipment and powerlines.

Electrical transmission and distribution lines crisscross California's forested landscape, including lands owned by the federal, state, and private landowners. The diversity of forestland ownership brings with it different laws and standards for the management of residual materials that are left after utilities conduct their powerline vegetation clearance activities.

H.R. 6012 seeks to reduce utility-related wildfire risk by breaking down barriers to the removal of dead, dying, hazardous, and fallen trees along utility corridors on Forest Service Lands. Specifically, the legislation allows the Secretary of Agriculture to provide permission to cut and remove trees and other vegetation near powerlines without

requiring a separate timber sale. Of particular importance, H.R. 6012 allows utilities to <u>remove fuel loads</u> from utility corridors after the clearances are created without the Forest Service having to conduct a timber sale. This reduces the fuel load created by utility vegetation management operations, thereby mitigating the risk and intensity of future fires. Given our recent experiences related to the increased risk and fuel load created when residual materials from utility vegetation management operations were left of private and local government lands, H.R. 6012 is an important measure to ensure that those materials are not just left on the forest floor to fuel future fires.
