

# 2023-2025 WILDFIRE MITIGATION PLAN SUBMISSION WORKSHOP AGENDA AND EVENT DETAILS

The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public workshop on April 27 and April 28, 2023, on the 2023 Wildfire Mitigation Plan (WMP) submissions from Pacific Gas and Electric Company (PG&E), Southern California Edison Company (SCE), and San Diego Gas & Electric Company (SDG&E). The workshop will consist of five panels comprised of utility representatives and industry experts.

Each panel will begin with a brief 15-minute presentation from the electrical corporations, followed by a 45-minute panel discussion, a short break, and will conclude with up to 45 minutes for questions from the public.

Energy Safety wishes to invite members of the public, stakeholders, and local and regional agencies, boards, tribes, and commissions to participate in the workshop. Energy Safety is also accepting written public comments on the 2023 WMP submissions. Public comments on large electrical corporations' submissions are due by May 26, 2023.<sup>2</sup>


