#### State and Federal Legislative Update

Mary-Ann Warmerdam, Senior Vice President of Governmental Affairs, provided an update on key developments at both the state and federal levels.

At the state level, Ms. Warmerdam covered the release of the 2025–26 May Revise, with the Governmental Affairs Department's Rural Rundown expected later today. Policy Advocates Sarah Dukett and Tracy Rhine shared updates on bills within their respective portfolios, including RCRC-sponsored legislation.

At the federal level, Ms. Warmerdam noted that the Secure Rural Schools language was included in the federal spending package. Ms. Warmerdam also highlighted the recent RCRC Officers' Fly-In to Washington, D.C., where the Officers and Board Members participated in advocacy meetings and shared insights from the trip.
