Discussion on Predator Species Management

Staci Heaton, Senior Policy Advocate, led a discussion with the RCRC Board of Directors to gather feedback on the topic of predator species management. RCRC continues to engage state agencies on the growing conflict between predator species protections and rural public safety and agricultural needs.
